The nursing facility my Pawpaw stayed in was very good about having activities for the residents. Pawpaw loved going to Bingo. Let me tell you those little, sweet ladies could get hard core when it came to winning a round of Bingo! The nursing home also had an activity room with puzzles, books, and cards. My Pawpaw liked to play solitaire and I would watch him play. I had to disregard some of his playing antics, because he would mark his aces with a dot of black Sharpie so that he could cheat... at solitaire! We still laugh at the fact that he was not playing with anyone, but he still wanted to make sure that he had a perfect game of solitaire.

In the activity room, they had a sensory wall. At 12, I did not understand the significance of the wall with shoe strings, locks, and other things that the residents could fidget. Now, with more knowledge, I understand that the sensory wall was a strategy to get the residents to work their hands that could be immobile due to arthritis. The wall also kept the residents busy so they did not become restless.

Pawpaw liked to sit at a big table and watch me and a family member play Jenga. He did not play much, but he liked to watch the tower get taller and more unstable until I most likely pulled the wrong tile and it tumbled to the ground. He would always giggle and then tell us to set them back up.

In an attempt to rectify the issues at skilled nursing facilities, I have written in previous blog entries that in order to care for the individuals that cared for us along with this country, there needs to be changes in individualized healthcare plans, social opportunities, and staffing concerns. Making these changes would, in turn, ensure that the senior population of the country could live longer, with greater quality of life in their final years. Improving their final years would change the stigma around nursing homes. Being able to provide better quality care for our elderly population will allow for happier families and a better work environment for care staff.
